

## EXEMPTIONS FOR NON-RESIDENTS

### PERSONAL EFFECTS

A non-resident may import free of duty and internal revenue tax, clothes, jewelry, toilet articles, cameras and similar personal articles owned by him if the articles are appropriate and intended for his personal use and not for resale. Jewelry or similar articles or personal adornment valued at US\$400 or more, cleared duty free under personal Customs exemption may not be sold within 3 years, unless duty is paid to the District Director of Customs in the USA. This duty must be paid before completion of the sale or the article will be seized.

### PROFESSIONAL TOOLS AND EQUIPMENT

Professional tools and equipment are free of duty if they have been used by the owner and are in his possession at the time he enters the USA. This privilege does not extend to articles for use in a manufacturing establishment, for another person or for sale.

## GUIDELINES TO COMPLETION OF CUSTOMS FORMS

### PART I

1. Print your full name as it appears on your passport
2. Your date of birth
3. The date you will arrive in the USA
4. Your current US address, telephone number, passport number and VISA number
5. The name of the city in the USA where you, personally will clear Customs
6. The name of the airline or Cruise line by which you will travel to the USA
7. The names of those in your family who accompanied you on your flight/cruise (if any) plus their Social Security and Passport Numbers.
8. To be completed by Crown Pacific

### PART II

9. Check the box which applied to you
- 9A. Indicate the last country at which you resided abroad
- 9B. The length of time you were out to the USA
- 9C. Mark the box which applied to yourself
10. Read all paragraphs in A,B, and C. Check each box that applies to the contents of your shipment.

### PART III

To be completed by U.S. personnel and evacuees only. If this applies, fill in the date you departed from the U.S., attach a copy of your travel orders and the date your orders were issued.

### PART IV

- A. Mark the items, if any, contained in your shipment
- B. If foreign household effects are contained in your shipment, mark Box 7 or 8, as applicable.\*
- C. For returning residents only, mark the box or boxes applicable to the contents of your shipment
- D. If you marked any boxes in Part IV A, B or C, then please complete sections 1 to 4.
